## **EXECUTIVE SUMMARY**

According to the U.S. Bureau of Labor Statistics (BLS), the number of people in the labor market who earn a certification/license has increased over the last 50 years in the United States. The San Diego-Imperial Center of Excellence for Labor Market Research (COE) analyzed data from online job postings to identify trends in the types of certifications/licenses requested by employers in Imperial County. This labor market information is intended to be used by the San Diego and Imperial Counties Community Colleges to guide meaningful discussions about ways to support the attainment of certifications/licenses in the region.

#### **KEY FINDINGS**

## CERTIFICATIONS/LICENSES IN THE TOP 20 EACH YEAR, 2011-2020

112 CERTIFICATIONS/ LICENSES IN THE TOP 20 ONCE OR MORE Between 2011 and 2020, 112 certifications/licenses made the top 20 certifications/licenses one or more years in Imperial County. Comparing recent years (2016-2020) with previous years (2011-2015) shows a shift in demand for certifications/licenses: one made the top 20 more often in recent years than previous years, and ten made the top 20 more often in previous years than recent years.

CERTIFICATIONS/ LICENSES IN THE TOP 20 EVERY YEAR

Between 2011 and 2020, ten certifications/licenses made the top 20 certifications/licenses every year in Imperial County. Nine of those certifications/licenses made the top 20 every year in both Imperial County and California.

## **CERTIFICATIONS/LICENSES RANKED BY ONLINE JOB POSTINGS**





## **CERTIFICATIONS/LICENSES TRENDS DURING THE PANDEMIC**

Based on certifications/licenses ranked by the number of online job postings in 2019 compared to 2020, the certifications/licenses featured below increased or decreased in ranking the most during the pandemic.



## NATIONAL MEDIAN EARNINGS WITH/WITHOUT A CERTIFICATION/LICENSE

According to national data from the BLS, median yearly earnings across all occupational categories were reportedly higher with a certification/license than without a certification/license in 2020. The three occupations with the greatest differences in median earnings are featured below.



#### **Data Source and Important Disclaimer**

The data presented in this report was derived from Burning Glass Technologies, "Labor Insight Real-Time Labor Market Information Tool." This report examines the most recent data available at the time of the analysis; however, data sets are updated regularly and may not be consistent with previous reports.

## INTRODUCTION

Obtaining a certification/license is one way that workers can advance in a field and distinguish themselves in the job market. According to the U.S. Bureau of Labor Statistics, the number of employed people with a certification/license has increased substantially over the last 50 years in the United States, and more than 24 percent of employed workers in the labor force held a certification/license in 2018.² There are numerous reasons why obtaining a certification/license can be beneficial. For one, it can demonstrate a worker's aptitude in a field or position, and through it, employers can determine that a worker has a baseline level of skill or mastery to perform that job. Certifications/licenses can also be important for advancement within a career and may even be required to be employed in a specific position, such as obtaining a job as a *Licensed Clinical Social Worker*. In 2018, nearly 85 percent of people nationwide with a certification/license indicated that it was a requirement for their job.³ When considering educational attainment, 34 percent of employed workers with an associate degree across the United Stated also held a certification/license in 2020.⁴ Given these national trends and the notable relevance of certifications/licenses across the United States, the San Diego-Imperial Center of Excellence for Labor Market Research (COE) developed this report to provide insight into certifications/licenses that are requested by employers in Imperial County.

To identify the types of certifications/licenses that are relevant to employers in Imperial County and evaluate trends within the region, the San Diego-Imperial COE reviewed online job postings. To explore trends over a notable period of time, the COE reviewed all online job postings between 2011 and 2020 in Imperial County. Within that timeframe, the COE identified the certifications/licenses that appeared in the top 20 each year and noted any trends in the certifications/licenses that were requested by employers in recent years (2016-2020) compared to previous years (2011-2015). For the certifications/licenses that appeared in the top 20 every year between 2011 and 2020, the COE also summarized more detailed and recent (2018-2020) information for these certifications/licenses including: minimum educational attainment posted, top occupation requesting certification/license, and entry-level salaries in Imperial County and California. A recent timeframe (2018-2020) was used for these data points to provide colleges and consumers with current information about the top certifications/licenses in Imperial County.

#### **CERTIFICATION/LICENSE DEFINITIONS**

First, it is important to define the terms certification and license in order to understand the similarities and distinctions between each, and why they are valued by employers. Certifications and licenses can similarly demonstrate skill, knowledge, and aptitude. In some cases, both can serve as alternate signifiers of educational attainment because reaching a certain level of education may be required to obtain that certification or license.<sup>5</sup> Additionally, both certifications and licenses may be renewed periodically, and proof of continuing education is submitted to the issuing entities to ensure that current standards are maintained. The primary distinction between certifications and licenses is the governing bodies that issue and oversee them. A certification is awarded by a third-party organization or industry association that standardizes the assessment process to ensure that a candidate has met a specific set of standards or skills, whereas a license is issued by a government agency and is often required for some professional practices like health, education, and legal careers. It should be noted that a person can obtain multiple certifications or licenses. Detailed definitions of each are provided below.

#### WHAT IS A CERTIFICATION?

A **certification** is endorsed by a third-party major industry association that creates a standardized assessment process to ensure that a candidate has met a set of standards that are relevant to perform a job or skill. Although certifications may include both education and exam requirements, the issuing entity may not necessarily offer the training directly. The assessment is standardized, however, even if the educational training is acquired through different institutions. This ensures that while an employer may not necessarily recognize a candidate's phlebotomy educational training, for example, they will recognize a Phlebotomy Certification and its requirements. The credibility of the certification is also generally dependent on the standards of the issuing industry association and some certifications may be perceived as challenging, while others may necessitate few requirements. Examples of certifications include Advanced Cardiac Life Support (ACLS) Certification or Project Management Professional (PMP).

#### WHAT IS A LICENSE?

A license is issued by a government agency, typically a state government, is executed by licensing boards, and is intended to show that a candidate has met a specific competency standard to perform a job, service, or professional activity. For jobs that require a license to perform a job or service, failure to comply with licensure requirements can result in significant fines or legal consequences. Like certifications, most licenses include some type of training and exam requirements, but may also include a combination of degree attainment, educational certificates, apprenticeship, supervision, or work experience. Examples of licenses include a Teaching Credential or Licensed Vocational Nurse.


The following sections will explore trends in the types of certifications/licenses most requested in online job postings, provide a comparison between certifications/licenses requested in Imperial County and California, evaluate trends during the COVID-19 pandemic in Imperial County, and show national median earnings data comparing earnings with and without a certification/license.

## **CERTIFICATIONS/LICENSES IN ONLINE JOB POSTINGS**

The San Diego-Imperial Center of Excellence for Labor Market Research (COE) analyzed data from online job postings<sup>6</sup> to determine the percentage of total online job postings that requested a certification/license. Between 2011 and 2020, there was an average of 4,793 online job postings per year in Imperial County (Exhibit 1), and 50 percent of online job postings or higher listed a certification/license every year since 2016. More recently, there was an increase in the total number of online job postings between 2019 (5,888) and 2020 (6,114), but a lower percentage of employers that requested a certification/license in 2020 (69 percent) compared to 2019 (78 percent). Please note that online job postings do not equal labor market demand; demand is represented by annual job openings. Employers may post a position, including those that require a certification/license, multiple times to increase the pool of applicants or post positions that require a license/certification, for example.

# CERTIFICATIONS/LICENSES IN THE TOP 20 EACH YEAR, 2011-2020

To identify certifications/licenses that were most requested by employers, this report analyzed the certifications/licenses in online job postings between 2011 and 2020 in Imperial County.9 Exhibit 2a lists the certifications/licenses that were in the top 20 certifications/licenses each year, and results demonstrated that 112 were in the top 20 one or more years between 2011 and 2020. Ten were in the top 20 certifications/licenses every year. Exhibit 2a provides links to additional information about each certification/license, but please note that these links may be outdated at a later time. Note that some positions below may be duplicated if employers call a certification/license by different names, for example.

To show trends regarding the certifications/licenses requested by employers in recent years, Exhibit 2b highlights the certifications/licenses from Exhibit 2a that made the top 20 list three or more times in recent years (2016-2020), but once or less in the previous five years (2011-2015). One certification/license made the top 20 list more often in recent years.

#### HIGHLIGHTING NEONATAL RESUSCITATION PROGRAM (NRP)

The Neonatal Resuscitation Program (NRP) certification is an education program of the American Academy of Pediatrics (AAP) and the American Heart Association (AHA) that teaches an evidence-based approach to newborn care. According to the American Academy of Pediatrics (AAP), NRP "utilizes a blended learning approach, which includes online testing and hands-on case-based simulation/debriefing that focus on critical leadership, communication, and team-work skills." Between 2016 and 2020, the top occupations in online job postings that listed this certification in Imperial County were Registered Nurses; Emergency Medical Technicians and Paramedics; and Medical and Health Services Managers. The top employer in Imperial County was "Pioneers Memorial Healthcare District." According to Burning Glass's salary estimates, the median salary for this certification was 58K in Imperial County.

To show trends regarding certifications/licenses that were not requested by employers in recent years, Exhibit 2c highlights the certifications/licenses from Exhibit 2a that made the top 20 list once or less in recent years (2016-2020), but three or more times in the previous five years (2011-2015). Ten certifications/licenses made the top 20 list less often or not at all in recent years.

### HIGHLIGHTING THE TYPING CERTIFICATION

According to the <u>City of San Diego</u>, the Typing Certification must be "obtained from an accredited business college, educational institution, public agency, professional service or business which routinely provides typing verification documentation in their normal course of business." For the certification, the following are measured: the duration of the test, how many uncorrected words per minute, number of errors, and the net words typed per minute. Between 2011 and 2020, the occupation that requested this certification the most in Imperial County was Word Processors and Typists. According to Burning Glass's salary estimates, the median salary for this certification was 35K in Imperial County.

# TOP CERTIFICATIONS/LICENSES RANKED IN IMPERIAL COUNTY

Between 2011 and 2020, ten made the top 20 certifications/licenses every year in Imperial County (see Exhibit 2a). Exhibit 3 displays these certifications/licenses re-ranked by the total number of online job postings within that timeframe. The three most requested certifications/licenses by employers were Driver's License; Registered Nurse; and First Aid CPR AED. Exhibit 3 also provides recent data regarding the minimum education advertised by employers and the occupation that requested the certification/license most in online job postings within the last three years (2018-2020).

# TOP CERTIFICATIONS/LICENSES IN IMPERIAL COUNTY AND CALIFORNIA

Exhibit 4 summarizes the certifications/licenses that made the top 20 certifications/licenses every year in Imperial County and/or California. Nine certifications/licenses made the top 20 every year in Imperial County and California, one made the top 20 list every year in Imperial County only, and three certifications/licenses made the top 20 every year in California only. Within the last three years (2018-2020), the certifications/licenses with the highest entry-level earnings in Imperial County and California were Project Management Professional (PMP); Certified Registered Nurse Practitioner; and Project Management Certification.

## **CERTIFICATIONS/LICENSES TRENDS DURING THE PANDEMIC**

The COVID-19 pandemic resulted in unprecedented changes in the economy that may have shifted priorities for the types of certifications/licenses requested by employers. Exhibit 5a shows certifications/licenses that increased in demand during the pandemic, which was defined as certifications/licenses that increased in ranking between 2019 and 2020 based on the number of online job postings. The certifications/licenses with the greatest increase in ranking were Certified Nursing Assistant; DEA Certificate; and Licensed Mental Health Counselor (LMHC).

## NATIONAL MEDIAN EARNINGS WITH/WITHOUT A CERTIFICATION/LICENSE

The Bureau of Labor Statistics (BLS) published national median earnings for full-time wage and salary workers (35+ hours) by certification/license status for 2020 (Exhibit 6).<sup>13</sup> Although this type of information is not available at a regional level for Imperial County, this national data can provide insight into differences in national median earnings based on certification/license status. Across all occupational categories developed by the BLS, national median earnings for workers were higher with a certification/license than without a certification/license in 2020. Occupations with the greatest differences in median earnings with a certification/license were Legal Occupations; Healthcare Practitioners and Technical Occupations; and Construction and Extraction Occupations.
